February 11, 2019

The Stillwater Township Board of Education met on February 11, 2019, at 7:00 p.m. in the Stillwater School Library for a Committee of the Whole Board of Education Meeting.

The meeting was called to order by Dennis DeGroat at 7:00 p.m. In accordance with the New Jersey Open Public Meetings Law, the time, date and location of this meeting was provided to the New Jersey Herald & Township Journal on January 8, 2019 and the Star Ledger on January 17, 2019. Notices were posted in the Stillwater School, Town Hall, Lakeland Bank, Stillwater Post Office, Middleville Post Office, Swartswood Post Office and the Stillwater School Website.

Motion made by Mrs. Nothstine, second by Mrs. LoCascio to approve the Superintendent employment contract with William Kochis dated July 1, 2019-June 30, 2024 at a salary of \$127,000 for the 2019-2020 school year. \$130,302 (increase of 2.6%) for the 2020-2021 school year, \$133,168.64 (increase of 2.2%) for the 2021-2022 school year, \$136,098.35 (increase of 2.2%) for the 2022-2023 school year, \$139,092.51 (increase of 2.2%) for the 2023-2024 school year. The employment contract was approved on February 11, 2019 by the Executive County Superintendent. A roll call vote was taken and unanimously approved.

The March 11th BOE meeting may have to be rescheduled. The committee also discussed the loss of state aid and the impact over the next 6 years. We also begin looking at projected revenues and expenditures.
